The U.S. Code does not include regulations issued by executive branch agencies, decisions of the Federal courts, treaties, or laws enacted by State or local governments. Regulations issued by executive branch agencies are available in the Code of Federal Regulations. Proposed and recently adopted regulations may be found in the Federal Register

Title 21 Food and Drugs covers poultry and poultry inspection; Animal meats, inspection, and dairy products; pesticide monitoring; drug abuse prevention and control; drug abuse prevention, treatment, and rehabilitation; and more.

Title 22 Foreign Relations and Intercourse, Sections 1-2141 F covers the Diplomatic and Consular Services; Passports; Foreign Service Buildings; Foreign Agents and Propaganda; Foreign Service; Protection of Citizens Abroad; Middle East Peace and Stability; International Travel; National Tourism Organization; and more.
